A similar survey was conducted in the United Kingdom in the late 1990's and in Australia in 2006. The results of the Australian survey were quite staggering and have been extremely valuable in representations to Government and to those who want to remove *old cars* from the road.

The UK survey is currently being undertaken again and it is also including clubs in the EU countries. Hence we also will continue our Australian data collection.
